You understand this and agree to assume the risk for yourself, your family, guests and any minor children in your care. Your participation in any **ROUGHWHEELERS 4WD CLUB** event is optional.

Participation is voluntary; if you are concerned about a particular situation or your ability in any way, do not tackle the obstacle or continue your participation, as may be applicable. In addition to known risks of **ROUGHWHEELERS 4WD CLUB** activities, there may be unanticipated or unknown risks

and dangers that can cause serious bodily injury or death. You acknowledge that you know this. You expressly assume all risk of your participation and damage, injury or death that may occur during or related to **ROUGHWHEELERS** or **ROUGHWHEELER 4WD CLUB** related events, whether caused by your own negligence or that of club officers, directors, run leaders, members, guests or third parties. You assume these same risks for your family members, guests and minor children in your care. Do not come or bring people who are not prepared to assume these risks.

You, on your behalf and for others with you (including any minors), agree to release the club and everyone else from liability and promise not to sue. If you (including for minors in your care) or your guests are unwilling to make this promise, do not attend the ROUGHWHEELER OR ROUGHWHEELER 4WD CLUB related event. In consideration for being invited or permitted to participate in **ROUGHWHEELER OR ROUGHWHEELER 4WD CLUB** related activities, you hereby release the **ROUGHWHEELER** organization, its affiliates, affiliate organizations, officers, directors, run leaders, volunteers, members, guests, contractors, agents, owners and lessors of any premises or land used for club activities (together, "releasees") from any loss, claim or liability of any kind whatsoever, whether caused by the negligent act or omission of the releasees or otherwise while the undersigned is for any purpose participating in such event. You furthermore give this same release for your next of kin, heirs and assigns, family members, guests, and any minor children in your care.

If you, your family, guests or minors in your care cause any damage, loss or make a claim or decide to sue, you agree personally to defend, protect, indemnify and hold harmless the releasees identified above. You expressly assume financial and legal liability for all the risks of injury to yourself and persons who accompany you. In addition to the legal release above, you separately agree to defend, indemnify and hold harmless the club and the releasees from any claims, demands, liability, judgments, loss, costs, expenses, and attorney fees arising out of your involvement with the organization, irrespective of who caused the damage. **If you are unwilling to make this promise, do not attend any ROUGHWHEELER OR ROUGHWHEELER related events.**

You further agree that you will (i) inspect and maintain your vehicle in good mechanical condition, (ii) maintain valid insurance and vehicle registration as required by law, (iii) comply with applicable law regarding operation of a motor vehicle while under the influence of alcohol or drugs, (iv) ensure that all drivers have a valid driver's license, (v) otherwise comply with all applicable federal and state laws, and (vi) comply with Roughwheelers 4WD Club rules and pronouncements as may be amended from time to time.

Please note that this agreement is of a continuing nature and so long as you attend ROUGHWHEELER 4WD CLUB events, whether as a member or otherwise, you are bound by this agreement.

Your signature below signifies that you have read this agreement, including the liability waiver, release, and agreement to indemnify, and that you understand its terms.

YOU FURTHER UNDERSTAND THAT YOU ARE GIVING UP SUBSTANTIAL RIGHTS BY SIGNING THIS AGREEMENT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT AND INDUCEMENT.
